Authorization and Release for the Procurement of a Consumer and/or Investigative Consumer Report

I hereby authorize THE PORT AUTHORITY OF NEW YORK AND NEW JERSEY and its agents by and through its independent contractor to produce a consumer report and/or investigative consumer report on me.

These above-mentioned reports may include, but are not limited to, information as to my character, general reputation, personal characteristics and mode of living, discerned through employment and education verification; personal references; personal interviews; my personal credit history (if applicable to the position) based on reports from any credit bureau; my driving history, including any traffic citations, a social security number verification; present and/or former addresses; criminal and/or civil history/records; or any other public record.

I understand that I am entitled to a complete and accurate disclosure of the nature and scope of any investigative consumer report of which I am the subject upon written request to the independent contractor, if such is made within a reasonable time after the date hereof. I also understand that I may receive a written summary of my rights under 15 U.S.C. Sec. 1681 *et seq.*

I further authorize any person, business entity or governmental agency who may have information relevant to the above to disclose the same to THE PORT AUTHORITY OF NEW YORK AND NEW JERSEY or its agents, by and through its independent contractor, including but not limited to, any and all courts, public agencies, law enforcement agencies and credit bureaus, regardless of whether such person, business entity or government agency compiled the information itself or received it from other sources.

I hereby release THE PORT AUTHORITY OF NEW YORK AND NEW JERSEY, its independent contractor and any and all person, business entities and government agencies, whether public or private, from any and all liability, claims and/or demands, by me, my heirs or others making such claim or demand on my behalf, for providing a consumer report and/or investigative consumer report hereby authorized.

I understand that to the extent permitted by applicable law, disclosure of a felony criminal record does not automatically disqualify me from consideration for a World Trade Center Site ID Badge. I do, however, further understand that falsification of information on my application may be grounds for revocation of my World Trade Center Site ID Badge.

In order to verify my identity for purposes of the background investigation, I am voluntarily releasing my date of birth for my own benefit and fully understand that age is not a consideration for a World Trade Center Site ID Badge.

I have received a stand alone, consumer notification that a consumer report will be requested and used for the purpose of evaluating whether or not I will be granted a World Trade Center Site ID Badge with the attendant privilege of access to the World Trade Center Site consistent with the Terms and Conditions upon which the ID Badge is granted.

The authorization will remain on file and shall serve as an on going authorization for THE PORT AUTHORITY OF NEW YORK AND NEW JERSEY and its agents, by and through its independent contractor to obtain consumer reports and/or investigative consumer reports as described herein for the duration of the period in which I have a World Trade Center Site ID Badge.
